26 MINUTES

Members noted the minutes of the Planning and Highways meeting dated 10 July 2017 (approved at Full Council on 17 July).

MATTERS ARISING

Mr McGuinness reported that he had attended the LAC and they had approved the hybrid application at Land east of Knowle Lane. Members expressed their disappointment that there had been no community contribution and this could set a precedent with other planning applications.

Mrs Douglas thanked Mr McGuinness for speaking at the Local Plan meeting last week. Mr McGuinness reported that the Borough Council was taking forward their investigations into B & C with the consultation being prepared for early next year.
